

## 2025 TANNEHILL TRADE DAYS RULES AND REGULATIONS

A Park employee will be in the Edwards House the Friday before Trade Days to renew vendor spaces. They will also be in Farley field at the Hoot-N-Hollar pavilion on Sunday ONLY from 8:00am to 1:00pm to renew spaces. There are **NO REFUNDS OR ROLLOVERS** on paid spaces. This includes **RAIN or SICKNESS**. **This is a two-day event. If current vendors renew their spot and miss one or both days, it counts as an absence. If a current vendor misses two consecutive Trade Days, they will not be allowed to renew their space. NO PETS ARE ALLOWED. NO ALCOHOL IS ALLOWED. THIS INCLUDES VENDORS.**

**HOURS:** 8:00am to 4:00pm Saturday and Sunday. Vendors should keep booths open during these hours on both days. NO early take down of booth is allowed.

**SET-UP TIME:** You can set-up beginning at 7:00am the Friday before Trade Days or as early as 6:00am on Saturday and Sunday. Vendors who set-up in the wrong space will be required to move. **NO VEHICULAR TRAFFIC IN TRADE DAYS AREA BETWEEN 8:00AM AND 4:00PM. Those who break this rule will be trespassed from the Trade days area.** Dealers with a shed space must move their vehicles to the general parking area. ALL merchandise must be contained in your shed space. There will be no early dealer arrivals in Farley Field on Thursday. Vendors cannot set up in Farley Field until Friday at 7:00am. Vendors must not camp in the TRADE DAYS area unless they are in their paid space.

**SPACE:** Displays, tables and all merchandise must be **(2) two feet back from the edge of the road or walkway to allow room for emergency vehicles.**

**ELECTRICITY:** Due to the potential of overloading the electric system and creating safety problems with extension cords, ONLY the vendor with a paid electric space is allowed to plug in at that site.

**RENEWAL OF REGULAR AND OVERFLOW SPACE:** TRADE DAYS dealers have the option to renew the space they have one month at a time. A Park employee will be at the Hoot-N-Holler pavilion SUNDAY ONLY from 8:00am to 1:00pm for dealers to renew their space. Any space not renewed by 1:00pm on Sunday will be available to rent to the public for the next month on the Tuesday after Trade Days starting at 8:00am. NO spaces will be renewed or sold on the Monday after Trade Days.

**SALE OF THE FOLLOWING IS PROHIBITED:** The park's contract for food/drink concessions prohibits anyone other than the person who has the contract or one of the appointed agents to sell drinks or prepared foods such as cookies, candies, sandwiches, cakes, canned or bottled soda and water. Real or toy weapons of any type, ammunition, unlicensed or counterfeit copyright merchandise, animals, snap-pops, fireworks, explosive devices, tasers, stun-gun, brass knuckles, chemical defense spray, profane or pornographic material, games of chance, merchandise or signs displaying marijuana plant or cannabis plant, tobacco, CBD oil, CBD products, anything considered as drug paraphernalia. Drug paraphernalia refers to any equipment that is used to produce, conceal and consume illicit drugs. It includes but not limited to items such as bongs, roach clips, miniature spoons and various types of pipes or any other item(s) deemed by the Parks Superintendent, Park Ranger, or the Alabama Historic Ironworks Commission are strictly prohibited. No spaces will be sold for advertising or taking donations.

**CLEAN-UP:** Trade Days dealers must clean up their space(s). Take all garbage, boxes, etc. to dumpsters in back parking lot.

### **GENERAL RULES:**

1. No skates, roller blades, skateboards, recreational scooters, bicycles or vehicles are allowed in the TRADE DAYS area during market hours.
2. All park camping regulations will be enforced where applicable in the TRADE DAYS area. Quiet hours are 10:00pm until 6:00am. Only well-maintained muffled generators may be used and they must be turned off during quiet hours. Smoky or noisy generators are prohibited.
3. Tannehill Ironworks Historical State Park is not responsible for dealer merchandise or personal property.
4. Vendors are responsible for collecting and paying all applicable sales tax. Alabama tax is 4% and Jefferson County tax is 2%. Please contact the Alabama Department of Revenue or Jefferson County if you have questions.

5. **Everyone coming in the park Friday, Saturday and Sunday of Trade Days weekend must pay park admission. Dealers and their helpers who go in and out during these days must show their current Trade Days pass at the gate or they will be charged gate admission. NO EXCEPTIONS!!!!**

If you lose your passes, they will not be replaced under any circumstances.

If you are a vendor and occupy one space you will receive 2 car passes for admittance. If you occupy 2 or more spaces you will receive 3 car passes. No exceptions. **Please be aware that violation of Trade Days or Park Rules could result in you being asked to leave.**
